I, being of lawful age, in consideration for being able to participate in a Trip to Haiti where I will learn about and see various locations where water purifications systems and sanitation systems have been installed, water filters are or may be manufactured, and participating in other activities to learn about the people of Haiti, do, for myself, my heirs, my executors, administrators, and assigns, hereby release and forever discharge Pure Water for the World, Inc., its employees and directors, successors, and assigns, from any and every claim, demand, action or right of action, of whatever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injury, known or unknown, debt or property damage that may occur at any time during my participation in the Trip and any activities in connection therewith, whether by negligence or otherwise, caused by anyone involved with the Releasee in anyway. This release relates to any risks whether foreseen or unforeseen.

I further release any and all individuals associated with Releasee from any claim whatsoever on account of first aid, treatment, or service rendered during the Trip.

I waive any right, claim, demand that might or could arise from any activity in which I participate while on the Trip.

I understand and agree that Releasee, its employees and directors, may not be held liable in any way for any occurrence in connection with my participation in the Trip. I further agree to save and hold harmless Releasee, its agents, employees, and directors, from any claim by me or my family, estate, heirs, assigns or executors, arising out of my participation in this Trip.
