
- Program Expenses: \$961,454 (85.2%)

SNAPSHOT OF FY2018 RESULTS:

- Reached 14,080 children and adults in Haiti and Honduras with the tools and education for life-changing safe water solutions.
- Trained 708 Community Agents (volunteers), who support families in their respective communities with the correct and consistent use of clean water and sanitation tools and safe hygiene practices.
- Completed 1,001 monitoring and evaluation visits to homes and schools, reinforcing the long-term success of the programs.
- Led the construction of 5 rainwater-harvesting systems and laid 12 km PVC piping systems, supplying water to schools that previously had no sustainable source.
- Conducted 29 WASH (water, sanitation and hygiene) workshops, covering 19 topics, providing essential skills to 703 individuals.
- Completed 732 tests in the Water Quality Testing Lab in Haiti.
- Hosted 58 volunteers in Honduras and Haiti, who took action to create lasting change.
